 Bitfount has developed a scalable and secure AI software platform that enables training and sharing of AI models on multiple separate

data sets, without moving or compromising the security of the data.

- The company is initially targeting the high-value pharmaceutical medicine development sector as its primary market, enabling much more efficient clinical trial recruitment in ophthalmology hospitals by securely applying AI to hospital records.
- In the medium term Bitfount plans to expand into other areas of clinical trials and then beyond pharmaceuticals into other sectors where proprietary data sets cannot be used for Al models


