
Objective and Philosophy

- For these purposes, positive environmental and social benefits include increasing low-carbon energy capacity, generating low-carbon energy, or providing assets that facilitate essential services including transport, healthcare, education, and digital connectivity.
- These environmental and social benefits are provided by investing in companies which have a good 'footprint' (which is the environmental and social impact of their day-to-day operations) and a good 'handprint' (which is the scope of the individual company's goods and services to actively decarbonise an economic sector or provide a positive social outcome).


